# Summary





Competency restoration can be a multifaceted and complicated issue. JCMH and HHSC have developed an initiative to assist counties in reducing their competency restoration waitlist and expediting the processes when a defendant is deemed incompetent or if the defendant has returned from state hospital unable to be restored. The presentation covered:

• Eliminate the Wait—how to use this Toolkit to make sure your county is considering all diversion options including Jail In-Reach

• Q&A about issues dealing with competency what to do when people come back from SH when they cannot be restored, working with Civil Courts for commitment or court-ordered medications

• The first draft of a new checklist for pretrial services. Previously, the toolkits included checklists for LMHA/LBHA/LIDDA and other Providers, Police, Sheriffs and Jail Administrators, Judges and Court Staff, Prosecutors, Defense Attorneys, and the State Hospital System. JCMH requested the assistance of pretrial services to finalize the checklist.
