## Request for Proposals

The Texas Judicial Commission on Mental Health (JCMH) will host its 5<sup>th</sup> Annual Judicial Summit on Mental Health November 2 - 4, 2022, at Great Wolf Lodge in Grapevine, Texas. The Summit will be presented live and virtually, but speakers will need to attend in person. Approximately 400 in-person and 1000 or more online attendees are anticipated.

**JCMH is now accepting proposals to present at the 5<sup>th</sup> Annual Judicial Summit on Mental Health.** This year, the Summit will continue to address topics across the sequential intercept model, and the second day of the Summit will be divided into two tracks: Adult and Juvenile. Some topics of interest this year include:

### Plenary

- Solutions for Reducing Implicit Bias, the Stigma of Mental Illness, and the Trauma from Involvement in the System
- Best Practices regarding Risk Assessments
- HIPAA and Data Sharing Between Entities

### Adult or Juvenile Track

- How your county or organization has successfully implemented *Eliminate the Wait*
- Developing Outpatient/Jail-Based Competency Restoration Programs
- Improving the System from the Lived Experience Perspective
- Mental Health Court experts to participate in a Mental Health Courts “stump the expert” Q&A session.
- Litigating MH or IDD Cases to a Jury (to include a discussion on Mens Rea)
- Lessons from SIM Mapping
- Building Resilience at Different Life Stages
- Ethical Prosecution and Defense of Juveniles or Adults with Mental Illness or IDD
- Treating the Whole Family to Effect Long Term Change in the Juvenile System
- Issues unique to the IDD community

### Civil Commitment

- Dismissing the Criminal Case and Transferring to Civil Court under CCP art. 16.22(c)(5)
- AOT Courts/Programs
- Court-ordered Medication (process, procedures, benefits, upholding a client’s civil rights, etc.)
- Options when a Person is Found Unlikely to Restore to Competency in the Foreseeable Future

While JCMH will accept and schedule sessions that cover a wide range of topics, we are especially interested in presentations that: are geared toward rural communities; examine the unique needs of justice-involved veterans; and include family-centered practices, trauma informed care, person centered practices, resilience, equity, and inclusion. JCMH strongly encourages proposals for sessions that present research findings, feature data analysis, or highlight evidence-based justice reform practices.

## JCMH Summit Selection Criteria

The selection process is competitive. Proposals will be selected based on their relevance to the field; ability to address multidisciplinary policy/program areas; engaging format; interactive design; style, clarity, and originality; relevance to JCMH stakeholders; cohesion with the full Summit agenda; and the subject matter expertise and training experience of the presenters.

- If proposing a panel format, a maximum of three (3) panelists and one (1) moderator is allowed.
- When completing the “Presentation Description” portion of this application, please craft language so that it could be included on the Summit website to describe your session.
- 2022 JCMH Summit speakers agree to provide JCMH with preliminary electronic copies of any handout materials for their session(s) no later than **Friday, September 16, 2022**. All handouts will be submitted to state accreditation boards for continuing education credit approval. Presentations will also be reviewed by the JCMH Summit staff.
- Speakers also agree to provide JCMH with final electronic copies of any slide decks and/or handout materials for their session(s) no later than **Friday, October 7, 2022**. All materials, in PDF format, will be made available to attendees on the 2022 Summit Website.
- JCMH speakers are expected to register for the conference, as well as organize and reserve their own travel and lodging. Reimbursement for travel and hotel will be available to presenters through the JCMH.
- Applicants will receive a confirmation email verifying the receipt of submission. Incomplete applications will not be accepted and will be returned to the sender for completion.
- If your presentation is selected, we will notify you of your selection, and send you the proposed agenda as soon as it is available.
- Presenters are encouraged to distribute business cards, contact information, and website references to workshop participants.
