Plenary Session – Early Intervention, Deflection, and Diversion: From the Public Health System to Intercepts 0 (Community Services) and 1 (Law Enforcement) – Capitol View Terrace

Using the Sequential Intercept Model (SIM) as a framework, this multidisciplinary panel will share practical solutions and evidence-based practices pre-arrest in the public health system and communities in the Southern Region, including law enforcement alternatives, a continuum of crisis services, and involving civil commitment practices and assisted outpatient treatment. Early intervention with and diversion from the criminal justice system are the preferred strategies for as many persons with serious mental illnesses as feasible. 988 implementation strategies will also be addressed.

Plenary Session – After Arrest: From Intercept 2 (Initial Detention) to Intercept 5 (Community Corrections) – Capitol View Terrace

Building on the earlier panels, and again using the SIM as a framework, this panel will highlight effective practices and models within the justice system if a defendant with mental illness is arrested, ranging from behavioral health assessments in the jail, pretrial release programs, to competency determinations and restoration treatment, court calendars and dockets, and community-based alternatives and treatment.

Though often viewed at the individual level, nearly every criminogenic risk factor can be traced to familial, neighborhood or structural origins. Further, the social determinants of mental health are shaped by societal systems - and in turn by the systemic inequities that permeate them. Approaches and interventions that fail to account for this context and its myriad, ubiquitous 'isms are primed to perpetuate inequity. This panel will explore criminogenic and mental illness risk factors in social and structural context and describe key principles in considering - and accounting for - these issues in justice-involved individuals living with mental illness, with a particular focus on improving responses to children, youth and families, and our communities.
