Welcome and Announcements

Justice Jane Bland opened the meeting and announced the appointment of Judge Gina Parker, Texas Court of Criminal Appeals, as Deputy Liaison to the Texas Judicial Commission on Mental Health. Judge Parker has extensive experience with the criminal justice system as a prosecutor and criminal defense attorney.

Judge Gina Parker shared how mental illness and substance use disorders underlie many of our society's struggles as seen through her experience as a prosecutor, criminal defense attorney, and judge. Judge Parker previously started a manufacturing company that hired people who have been incarcerated to help reduce recidivism. She recognized the importance of the JCMH's work and expressed optimism for the future.

Judge Jesse F. McClure III reintroduced himself to attendees. He serves as a JCMH Chair after his elevation from Deputy Liaison. He served as the Deputy Liaison from the Texas Court of Criminal Appeals since 2021. Judge McClure has experience serving as a prosecutor and as a District Court Judge.

Justice Rebeca Huddle shared updates from the Supreme Court's Children's Commission, where she serves as Deputy Chair. The Children's Commission has started a Consortium on Trauma Informed Court Practices. The Consortium provides a statewide bi-monthly forum for judges handling child welfare cases to learn about trauma-informed and trauma-responsive court practices.

Executive Director Report

Kristi Taylor, Executive Director, thanked all attendees for their work and support of the commission. Ms. Taylor provided an update on the Court Liaison Program. This was a pilot program that supported three counties by funding a Court Liaison role with step-downs in financial support over the 3-year program. JCMH piloted the program in Grayson, Denton, and Smith counties. JCMH included in its legislative request an exceptional item for additional funding to expand the program to five more counties. Additionally, JCMH has contracted with the National Center for State Courts to write an evaluation of the first cohort of the program and an implementation guide. This guide would provide a step-by-step process to counties to implement the program in their courts, either receiving funding from JCMH or through other grants.

Ms. Taylor spoke at the Treatment Advocacy Center's (TAC) National Assisted Outpatient Treatment (AOT) Symposium with Collaborative Council members Daniela Chisolm and Dr. Patricia Ortiz on March 27th. TAC is hosting an AOT Workshop on June 5th and 6th in San Antonio, Texas. Ms. Taylor provided an explanation of AOT courts. It is a program that is run by the judge with probate jurisdiction through civil commitment laws. The program aims to facilitate treatment options for defendants accused of low-level offenses and assist

those who are possibly incompetent, but don't qualify for Mental Health Court. Judge Elaine Brown, Hays County Court-at-Law #3, who holds general jurisdiction, is opening an AOT Court in addition to her Mental Health Treatment Court. Her unique jurisdiction allows her to evaluate both programs for the best fit for each defendant.

Ms. Taylor noted that there are not many AOT Courts currently operating in Texas, but those operating or those interested in learning more or creating their own are welcome to join the Texas AOT Collaborative. Ms. Taylor leads the Collaborative with Daniela Chisolm. The next meetings are April 15th and August 15th.

Ms. Taylor announced the resignation of Molly Davis, Director of Operations. Ms. Davis will be leaving the JCMH to join an Office of General Counsel for Juvenile Probation. Ms. Taylor thanked Ms. Davis for her service.

Budget Update

Patrick Passmore provided an overview of the JCMH budget. As of March 2025, the JCMH had approximately 60% of its budget remaining and is on track with expenditures. JCMH ended Fiscal Year 2024 with approximately \$5,000 in unexpended funds and will carry those into the current fiscal year as unobligated funds.

Mr. Passmore reviewed the exceptional item requests for JCMH included in the Supreme Court's legislative appropriations request. The requests included operating costs, an additional full-time employee position, and a new and expanded phase of the Court Liaison Program. The Senate version of HB 1 included funding for all JCMH requests, but the House version of HB 1 only included funding for operating expenses. Mr. Passmore will provide an update on the outcome of the legislative session and JCMH budget at the next meeting.

<u>Legislative Update</u>

Justice Bill Boyce, JCMH Vice-Chair and Chair of the Legislative Research Committee, informed attendees that the Commission proposed thirteen pieces of legislation or amendments, and all were adopted the Texas Judicial Council.

Professor Brian Shannon, Paul Whitfield Horn Distinguished Professor, Texas Tech University School of Law, informed attendees that those recommendations were sponsored and introduced in the legislature by Senator Zaffirini in SB 1164 and SB 2213. They have been referred to the Senate Committee on Criminal Justice. SB 1164 contains proposals A-D and focuses on civil related provisions. SB 2213 contains the criminal related JCMH proposals. In the House, Representative Moody filed the respective companion bills HB 5463 and HB 5465.

Professor Shannon noted bills that were not drafted based on the JCMH recommendations but contain the same language or concepts:

- SB 643 from Senator Johnson, and its companion, HB 3163 from Representative Leach, match JCMH proposals for the clarification of venue for court ordered mental health services. As of April 3rd, the House bill has been voted favorably from the House Committee on Judiciary and Civil Jurisprudence, and the Senate bill has been referred to committee but not had a hearing.
- HB 1583 from Representative Hull would make similar changes to the Peace Officer Notification of Emergency Detention form as the JCMH proposed changes. This bill has been voted favorably as substituted from the House Committee on Homeland, Public Safety, and Veterans.

Professor Shannon announced that his book, the 7th edition of *The Texas Criminal Procedure and the Offender with Mental Illness*, has been published by NAMI.

JIR Update

Hon. John J. Specia, **Jr.**, Judge (Ret.) and JCMH Jurist in Residence, shared that he remains interested in the role of Judges as leaders and conveners. Judge Specia announced he and JCMH staff are creating a video and other resources for judges and others to learn how judges can be leaders while adhering to the judicial ethics.

Hon. Brent Carr, Judge (Ret.) and JCMH Jurist in Residence, reported that because a majority of Texas counties are not urban, he is interested in evaluating how to best help rural communities. To do so, Judge Carr is gathering a discussion group to brainstorm ideas and may form a committee.

Staff Updates

Molly Davis, Director of Operations, announced that on April 4th, JCMH finished the second cohort of the Treatment Courts Collaborative. This online discussion group is for judges interested in starting or improving a new a treatment court. The judges receive education on grants and data collection and are paired with experienced treatment court judges for mentorship. Over two years, ten judges have participated – serving 36 counties. Ms. Davis thanked Judge Carr for leading the Collaborative and Judge Elizabeth Leonard, Judge Camille Dubose, and Judge Selena Solis for serving as mentors.

Ms. Davis shared a heartfelt goodbye, and thanked the Executive Committee, Commissioners, Collaborative Council, and JCMH staff for their support over the years and dedication to the mission.

Kama Harris, Director of Policy and Education, informed attendees that registration for the Summit was open, and that the Summit had 300 registered attendees as of April 9th. JCMH is accepting scholarship applications and speaker proposals for the Summit. Ms. Harris announced the Summit Curriculum Committee will meet May 22nd.

Ms. Harris announced that the Adult Bench Committee will meet following the legislative session and complete the book before the Summit.

Andy Perkins, Staff Attorney, informed attendees that the JCMH continues to send out resource letters and Jurist-in-Residence letters to update recipients on programs, events, and resources across the state. JCMH continues to update the Innovations Map and asks attendees to help add more resources to the map.

Mr. Perkins provided updates on the Substance Use Disorder and Data committees. The Data Committee created a Best Practices Guide and is collaborating with the Office of Court Administration to further develop data collection guidance.

Kristi Taylor announced that Rose McBride received the Award of Excellence from the Texas CIT Association for her work on the JCMH podcast – Reimagining Justice.

Rose McBride, Communications Manager, reported that representatives from 120 out of 254 counties in Texas have registered for the Summit. Ms. McBride reported that JCMH is celebrating two years of the podcast, *Reimagining Justice*, with 24 published episodes. The podcast has been streamed 1471 times, and the top three episodes are "Multisystemic Therapy (MST) with Bailey Hagler," "Whole Person Project with Kirk Noaker," and "Pretrial Intervention with Lee Pierson." Ms. McBride presented a video highlighting the Reimagining Justice podcast.

OCA and Texas Judicial Council Update

Megan LaVoie, Administrative Director, Office of Court Administration, informed attendees that OCA signed a contract for a text reminder program in August, and the program provides reminders for all case types. Forty counties are signed up for the program and two counties (Tarrant & Cameron) have implemented it. The program is free for counties to opt into. Data has shown that text reminders can be one of the best ways to improve court appearances.

Ms. LaVoie informed attendees that OCA has published the 6-month reports for District and County Court performance. These reports are required per Section 72.083(b) of the Texas Government Code (HB 2384 88th R). The final reports to gather the full year are due November 1st.

Ms. LaVoie informed attendees that Erin Morgan, Specialty Courts Program Manager, OCA, is presenting to the Governor's Specialty Court Advisory Council on June 6th regarding best practices and data.

Ms. LaVoie provided a legislative update to attendees. There were over 5,600 House bills filed, over 3,00 Senate bills filed, and with some joint resolutions, the total was over 9,100 bills filed in the 89th Session. As of April 9th, 28 bills had already been sent to the Governor for signature. OCA had 1,983 fiscal note requests and had completed over 1,500 as of April 9th. The legislature has introduced eleven data positions to aid each administrative judicial region with data collection and case management in their budget, The Senate included funding for specialty court case management systems in their budget. Ms. LaVoie highlighted some additional Texas Judicial Council recommendations for the Commission to monitor although not related to mental health: SB 1996, HB5078; SB 2070; HB 5128; HB 1761, SB293; SB1575, HB452.

Justice Jane Bland highlighted the dedication of Megan LaVoie and the OCA staff and thanked them for their work.

Commissioner Updates

Hon. Oscar Kazen, Judge, Bexar County Probate Court No. 1, reported that his court has been working with Office of Court Administration to develop methods for accurately counting probate data. Judge Kazen will present at the Treatment Advocacy Center workshop in San Antonio on June 6th.

Professor Brian Shannon informed attendees that he and Kristi Taylor will be presenting at the Treatment Advocacy Center workshop. Professor Shannon reported that the Legislative Research Committee proposed legislation to transfer those facing nonviolent charges to outpatient civil commitment.

Steve Wohleb, General Counsel, Texas Hospital Association, noted that he has been hearing of problems from some of his constituent hospitals regarding the timeliness of medication orders with court-ordered mental health treatment. Mr. Wohleb called for the support of the Commission to lead discussions addressing this issue.

Hon. Devon Anderson, CEO, Justice Forward, noted a discrepancy between the waiting time for expunctions between people in drug and veterans' courts compared to mental health courts. People wait two years after probation in drug and veterans' courts compared to five years for mental health courts. Ms. Anderson informed attendees that Representative Ann Johnson filed HB 3261 to address this discrepancy.

Brandon Wood, Executive Director, Texas Commission on Jail Standards, reported that his commission is collaborating with Texas Commission on Law Enforcement on training

classes for justice-involved veterans and IDD) training for jailers. Mr. Wood reported the IDD Advisory Committee remains active and there were bills filed relating to IDD. He reported that they continue to monitor the impact of federal funding cuts on local mental health authorities and local IDD authorities as it relates to treatment services for those in the county jail.

Vickie Rice, Dallas County Public Defender's Office, reported that she will return to her previous role as a new chief public defender has been named. Dallas County is starting an AOT Court which will have a dedicated full-time position. Ms. Rice noted that there is much enthusiasm in the county for the program.

Lee Pierson reported that Metrocare Services received the grant to start that AOT Court in Dallas County and his office looks forward to utilizing the program.

Hon. Matt Hand, Judge, Potter County Court at Law No. 2, asked for ideas on ensuring defendants report to the local mental health authority on a personal recognizance (PR) or surety bond. He said the data shows that on PR bonds close to zero percent report to the local mental health authority and low participation on surety bonds.

Eric Smith, Founder, Eric W.T. Smith Consulting, stated that his clients are facing some of the challenges he faced himself over 15 years ago with AOT programs. These clients and their family often experience the criteria for emergency detention or civil commitment as too high a bar, and he hopes we can address these issues and better serve those with mental health needs.

April Zamora, Director of the Reentry and Integration Division, Texas Department of Criminal Justice (TDCJ), reported that her division is revamping many programs following the sunset process. The division is evaluating programs focused on substance use disorders, including Substance Abuse Felony Punishment Facility Program (SAFPF) programs for those on probation, and mental health screenings. Ms. Zamora reported that she will remain in charge of rehabilitation, re-entry, and the Texas Correctional Office on Offenders with Medical or Mental Impairments (TCOOMMI). Her division has also picked up the youthful offender program, aka Champions Youth Program, and the division is evaluating how to adequately serve those in the program with mental health needs. Ms. Zamora reported that TDCJ included funding for additional duly diagnosed residential beds in their legislative request, but they are nearing 37,000 people in their system that have a mental health condition.

Chief Stan Standridge, Chief of Police, San Marcos Police Department, reported frustration that his agency has been required to shift their focus to immigration, when there are other high priority issues. He stated that many police departments are in a fiscal predicament as the ad valorem tax revenue is decreasing and grants are being frozen, even while more work is being demanded.

Dr. Jennie Simpson, on behalf of **Scott Schalchlin**, Texas Health & Human Services Commission (HHSC), reported a continued decline of the forensic waitlist by 32% from 2500 to 1700, but noted that demand has increased every year since 2021. She reported that HHSC is making the Jail In-reach Learning Collaborative a statewide program available to all counties. She also reported that forensic support teams are currently being piloted in Dallas and Travis counties.

Dr. Evan Norton on behalf of **Shandra Carter**, Texas Juvenile Justice Department (TJJD), reported that TJJD have almost completed implementation of dialectical behavior therapy at all five secure facilities. Since 2022, TJJD has almost doubled its mental health professionals working in the state secure facilities. TJJD is in year two of a grant from the Office of Juvenile Justice and Delinquency Prevention for a mapping project with Meadows Mental Health Policy Institute (MMHPI). TJJD will collaborate with MMHPI to develop a 10-year strategic plan following the mapping project.

Matt Smith, Director of Statewide Youth Services Continuum, Texas Juvenile Justice Department, announced his new role at TJJD and thanked his former colleagues from Williamson County for 23 years of incredible work. He reported that Williamson County completed a three-year youth SIM-mapping project in partnership with Meadows Mental Health Policy Institute. An emerging issue he sees in most regions is school vaping. It is overwhelming the system and utilizing many detention beds. They are working with DFPS and schools to keep kids shallow in the system.

Hon. Tyra McCollum, Judge, Fort Bend County Court at Law No. 2, has a juvenile court and a veterans' court that hears both felonies and misdemeanors. The veterans court launched a peer mentor program. They wait six months after graduation to ensure stability before graduates become peer mentors. She also reported on a Fort Bend County program that presents a digital banner to advertise veterans' courts and other treatment courts on tablets utilized by the Sheriff's office at booking.

Hon. Victor Villareal, Judge, Webb County Court at Law No. 2, informed attendees his court has a DWI specialty court and a juvenile drug rehabilitation court. He noted that the juvenile drug rehabilitation court is known as the Youth Success Court to avoid stigma or negative connotations. In May, the court will have its first graduating class with seven individuals.

Dr. Courtney Harvey, Associate Commissioner, Texas Health & Human Services Commission, thanked Brandon Wood for his incredible work. She noted that there are additional provisions in the legislature that would expand HHSC's efforts and provide funding for programs such as dialectal behavioral therapy, multi-systemic therapy, and intensive outpatient treatment. Dr. Harvey reported that HHSC is collaborating with TJJD and the Department of Family & Protective Services to evaluate barriers to the work of juvenile justice and mental health providers and implement solutions.

Hon. Selena Solis, Judge, 449th District Court, reported on INSPIRE, an adult felony mental health court of two years. The specialty courts in El Paso are working together to evaluate alternate funding sources in the face of uncertainty. She is participating in the OCA workshop for best practices and needs ideas on developing buy-in from community stakeholders, including district attorneys. She also reported on a project with the University of Texas at El Paso called Shadows to Light, where poetry and literature are used to deal with trauma and expression of emotions. She recommended that the Texas Judicial Commission on Mental Health consider El Paso as a future Summit location.

Beth Mitchell, Litigation Coordinator, Disability Rights Texas, reported that she anticipates a decision in October following a bench trial in the ongoing lawsuit claiming unconstitutional pretrial detention in incompetency cases. She also commented on the need for more judicial training on IDD and related statutes and processes.

Hon. Cynthia Porter-Gore, Judge, City of Allen Municipal Court, reported an influx of 15-to-28-year-old men hallucinating after use of THC. She pointed to research that vaping concentrates THC and may result in the onset of schizoaffective disorders.

Magdalena Morales-Aina, Director of Community Supervisions and Corrections Department, El Paso County, stated that El Paso repurposed their gang unit to be FORGE (Fortitude, Opportunity, Responsibility, Gratitude, and Empowerment), for the 17 to 25-year-old transitional ages, who are difficult to reach and to treat. The unit has partnered with Big Brothers and Big Sisters to facilitate mentorship of those in 17 to 25-year-olds. Ms. Morales reported that she has partnered with the Sheriff's Office to pilot provides computers for those who are in custody for violations to complete the Texas Risk Assessment. This allows for them to identify what programs they are eligible for and approach the courts with this information, rather than wait on the court to order the assessment. Also, AllRise has a project with the Bureau of Justice Administration to create a new assessment for violence predictions and mental health to determine if a candidate must be detained pretrial. She would like to see Texas be involved as a validator.

Hon. Brandy Mueller, Judge, 403rd Criminal District Court, has a specialty court for emerging adults ages 17 through 24 in partnership with the probation department and the district attorney's office. They have monthly court settings, provide counseling, and include individuals with mental health, substance use disorders, or IDD. She noted that the wait time between arrest and when the services start for a defendant in her county can sometimes be years. For defendants, especially juveniles, this wait time can escalate the violence of their crimes faster without treatment. She asked for good ideas on how to confront the long wait times. Judge Mueller also noted that many jurors are experiencing trauma from the increase in body camera technology where jurors experience violent crimes during trials. She would like information and ideas around supporting jurors who have been traumatized, including exit interviews with counselors for jurors to help decrease mental health impact post-jury service.

Wayne Young, CEO, Harris Center, reported on Hospital to Homes, a crisis residential program for the unhoused discharging from psychiatric hospitals. They've had 50 to 70% reduced recidivism, 50 to 60% fewer new bookings, and 50% reduced utilization of services. He noted the abrupt withdrawal of funding amounting to a \$7.9 million reduction has forced the Harris Center to close 1/3 of those Hospital to Homes beds. Mr. Young announced that there would be an IDD juvenile justice virtual training in June.

Beth Lawson, CEO, StarCare Specialty Health System, reported a concern that the DEA might be rolling back flexibilities on telehealth. She commented that telehealth is the lifeblood of providing mental health treatment to rural or frontier counties.

Hon. Cynthia Wheless, Judge, 417th District Court, stated the JCMH Rural Issues Committee should look for ways to implement the regionalization that has occurred in 35 secured juvenile detention centers across the state because the program could serve as a good model for the rural counties. She also thanked the Commission staff and her peers on the Commission for the contributions that have guided her work.

Dr. Connie Almeida, Director of Behavioral Services, Fort Bend County, informed attendees about the history of her department. It was founded fifteen years ago by the Council of Judges to focus on the intersection of behavioral health and criminal justice. Today it is under the Commissioner's Court and has a staff of approximately 20 people who provide trainings focused on criminal justice. She reminded the Commission that Fort Bend County received a grant from the Department of Justice through the Office of Justice Programs for Second Chance, which supports children of incarcerated parents to promote successful reintegration. At a national conference at Arizona State University, she learned that a study in Minnesota showed that one of every six kids had been impacted by a parent who had been incarcerated. She is working on parenting programs in jail that support caregivers, address trauma, and ensure in-person visitation with children of incarcerated parents. She also noted that in Texas, more data around the subject is needed.

Hon. Larry Phillips, Judge, 59th District Court, has an adult felony mental health court and a competency court for status hearings—if anyone is found incompetent in Grayson County, they get transferred to his court. He informed attendees that he stepped down as president of the Texas Association of Specialty Courts at their annual conference in March, which had 550 attendees. The Texas Association of Specialty Courts accomplished one of its goals by ensuring that OCA had a dedicated specialty courts position. Judge Phillips highlighted the development of a specialty courts case management program. At the request of Rosie Medina, Judge Phillips recognized House Bill 1831 and Senate Bill 1431, which will allow more juveniles to enter specialty courts. Judge Phillips thanked JCMH staff and Commissioners for their work and highlighted the impact the JCMH has had in his community.

Denise Oncken, Mental Health Bureau Chief (Ret.), Harris County District Attorney's Office, announced her retirement after 39 years of service. She is currently serving on the board of the Albert Switzer Fellowship foundation and trying to recruit law, medical, and

public health students to work in the mental health field. Ms. Oncken is also working on homelessness in Harris County. She highlighted that the Houston Bar Association has a wellness committee.

Hon. Stacey Mathews, Judge, 277th District Court, noted that there were not as many ideas to borrow and share before the commission. She reported seeing cases and research about THC contributing to schizoaffective disorder occurrence. To address vaping and THC juvenile cases, Hutto ISD has partnered with the juvenile services department and the prosecutor's office to conduct a first offender program with additional juvenile services. She reported that a child welfare judge in Williamson County has created listening groups and public and private partnerships that are developing into a hub with resources for parents of youth in the juvenile justice system. The collaboration is breaking down silos between people who all want to help kids and their families. Regarding juror trauma, Williamson County created a handout and received approval from county commissioners to support the needs of jurors when they have experienced trauma, such as short-term bereavement counselors.

Hon. Sue Kurita, Judge, El Paso County Court at Law No. 6, announced she has been named the local administrative judge for El Paso and hopes to start right away with projects that better coordinate courts in the county and improve awareness with a training and CLE for judges.

Yolanda Lewis, Executive Vice President for Justice and Health, Meadows Mental Health Policy Institute, encouraged commissioners by saying other states are jealous that Texas has a Judicial Commission on Mental Health. Ms. Lewis noted that parental incarceration is a great risk factor for youth and MMHPI is striving to connect youth and these families with better grief response resources. Ms. Lewis reported MMHPI collaborated with Fountain House to conduct a study on the feelings of those calling 911 and the response was for behavioral or mental health concerns. The goal is to learn how to better respond to these calls, with publication of results soon. She noted that those with lived experience in the study did express concern for the wellness of the first responders too.

Hon. Rosie Speedlin-Gonzales, Judge, Bexar County Court at Law 13, reported on the REFLEJO Court. It is a trauma-certified court which offers treatment and substance abuse programming for first-time offenders of family violence. Graduates of the court have their case dismissed on the day of graduation and their expungement process begins right away. This is made possible by an agreement with the district attorney and the district clerk. Additionally, the court is adding a mental health track and expanding with a court director and new program manager. The court provides time management training for participants in phase one and incorporates art therapy for phases three and four. There will be a documentary and ten-episode podcast about the REFLEJO court to be released in 2026.

Hon. Nelda Cacciotti, Chief of the Mental Health Division, Tarrant County Criminal District Attorney's Office, reported she would like to see more education and training on justice-involved IDD populations, and specifically requested training on state-supported

living centers (SSLCs) so that courts and parties will know how they are being served. She would like attorneys and judges to understand what all is considered when deciding to transfer someone into the community from the SSLCs. Ms. Cacciotti reported that the attorneys in her unit visited their State Hospital and SSLC to bridge the gap in knowledge and communication. She reported an increase in questions on chemical dependency warrants and thinks there needs to be more discussion around this.

Adrienne Kennedy, Past National President, NAMI, has lived experienced and seen both the best and worst outcomes of AOT. Ms. Kennedy noted that in her son's case the AOT period was too short and at 90 days of treatment through AOT was just enough to make him upset and defiant, and not enough to really help him. Ms. Kennedy also reported that a local psychiatrist is very concerned about jury instructions on the insanity defense under Texas law. She recommends a book called "Nowhere to Go," which is free online. She also suggested education on anorexia as a mental health issue.

Guest Presentation

Justice Rebeca Huddle introduced Brian East, Senior Attorney at Disability Rights Texas. He has tried many cases in both state and federal courts, written and lectured extensively on disability rights, is a life member of the Texas Bar Foundation, and is an adjunct professor at the University of Texas School of Law.

Brian East presented a historical overview of the ADA before its 35th anniversary (July 26, 2025), covering the evolution of disability rights in the U.S., the shortcomings of constitutional protections, and how the ADA expanded civil rights for people with disabilities. He discussed Buck v. Bell (1927), a Supreme Court case that upheld forced sterilization of people labeled with intellectual disabilities, reflecting the influence of eugenics and minimal constitutional protections recognized for disabled individuals at the time. Later cases reaffirmed that disability receives the lowest level of protection under the Equal Protection Clause. Progress began with Section 504 of the Rehabilitation Act of 1973, which applied to federally funded entities and later to federal agencies. Other regulations were continually delayed until a series of protests from disability activists, including the historic 1978 San Francisco sit-in. The ADA emerged in the late 1980s following nationwide advocacy from the National Council on Disabilities, including the "Capitol Crawl," where disabled activists crawled the Capitol steps to show their dedication to the mission. Signed in 1990, the ADA has a much wider breadth and includes Title I (employment), Title II (state/local government), and Title III (private businesses/public accommodations). It mandates nondiscrimination, reasonable modifications, effective communication, and accessibility. It covers a broad range of public services—from courts and prisons to law offices—and enforces both architectural and communication access. Though the federal government is covered under different provisions, most state and local entities are fully subject to the ADA. The law is enforced by the DOJ and through private suits, with limited

immunity for state governments. President George H.W. Bush called the ADA a long-overdue "Independence Day" for Americans with disabilities.

Meeting Adjourned

Judge Jesse F. McClure thanked attendees for coming and announced the next commission meeting on October 6th, before the 8th Annual Summit, at the Royal Sonesta Houston Galleria in Houston, Texas.
