


How Pretrial Data Benefits Local Agencies



Types of Performance Measures

Output Measures

Quantitative measure of activity or work

Examples: number of arrests resulting in incarceration, number of assessments and releases

Outcome Measures

Measure of intended results or outcomes

Example: Reduction in instances of noncompliance or recidivism, Appearance Rate

Efficiency Measures

Effect of system and agency resources on program or goals

Examples: Cost analysis, program utilization, reduction in jail population, caseload ratios

Key Pretrial Measures

Court Appearance Rate

The percentage of released pretrial defendants who attend all scheduled court appearances.

Public Safety Rate

The percentage of released pretrial defendants who are not charged with a new criminal offense that occurred during the pretrial stage.

Return to Incarceration Rate

The percentage of pretrial defendants who subsequently returned to incarceration during the pretrial stage.

Success Rate

The percentage of released pretrial defendants who attend all scheduled court appearances and are not arrested or charged with a new criminal offense

Pretrial Detainee Length of Stay

The average length of stay in jail for assessed pretrial defendants after initial arrest.

No New Violent Crime Rate

The percentage of pretrial defendants who do not commit a new violent offense while under pretrial supervision.

Decision - Making Measures

Court Decision Concurrence

The percentage of pretrial defendants whose court -ordered release or detention status corresponds with their release protocol.

Recommendation Rate

The percentage of a PSA's recommendations that correspond with their assessed risk of pretrial misconduct and release protocol.

Court Order Concurrence

The percentage of pretrial defendants whose court order matches the pretrial release agency's recommendation.

Release Rate

The percentage of assessed pretrial defendants who secure release during the pretrial stage.


Identify Trends


 Use baseline data to show the state before your program and then use outcome data to demonstrate the positive changes and growth

The percentage of assessed pretrial defendants who secure release during the pretrial stage.




Court Appearance Rate:

The percentage of released pretrial defendants who were assessed and who are not charged with a new criminal offense during the pretrial stage






2021-2024 Apperance Rate Trend Analysis




2021-2024 Safety Rate Analysis

Data isn't meant to be hidden or not acted upon; effectively communicating data with stakeholders to promote program advancement is the key to the success of any Pretrial Executive.



Storytelling with Data

- Structure your communications with a beginning, middle, and end to create an engaging narrative.
- Combine the numerical data with human interest stories and client testimonials to make your impact relatable and memorable.
- Include tangible and intangible benefits of your program to illustrate a more meaningful impact.
- Don't just show numbers; explain what they mean and why they matter to your audience.





Choose the Right Visualizations

- Graphs and Charts: Use bar charts, line charts, and other visualizations to present trends and comparisons effectively.
- Infographics: Combine visuals, shapes, and minimal text to create easily digestible summaries of your findings.
- **Tables**: Present detailed data in a structured format.
- Newsletters : Create one -pagers to make data more digestible and less overwhelming for stakeholders
- Dashboard: Provide real -time access to key performance measures

CURRENT OVERVIEW:

In July, Pretrial Services served a total of 150 clients. These clients accounted for 4,680 days or 12.8 years in jail bed stays. To date the department has served 289 clients in 2025, 80% of the 2024 population served. The department continues to project a 20% increase in clients for 2025.

The program currently has 117 active clients, with an July average daily population of 151, a 15% increase. The majority of the current caseload, 60%, involves felony charges. Additionally, the program completed 39 arrestee evaluations and recommendations, including IRAS-PAT assessments, in the last month. There were also 27 new clients added to the program in July. Currently, we have an 88% Release Rate. 25 clients successfully completed the program.


65 clients, 55% of our population, are participating in voluntary individual counseling with our PAK Therapeutic Team. We currently have 3 clients voluntarily participating in inpatient treatment. We have secured 69 clients voluntary beds and admissions into inpatient treatment in 2025 thus far.

The July Jail Analysis showed that 15% of inmates are classified as Pre-Adjudication. The Cass County Jail population is 167 inmates: 134 Cass County, 22 Howard County, 11 IDOC. Currently, with expansion, the jail is at 54% capacity. It is estimated that without Pretrial Services the jail would be at 92% capacity. The low risk population is currently 4%, a 25% reduction in the past month. 51% of the population are identified as high risk, illustrating the reservation of jail resources for high risk inmates and maximized risk-based release decisions.

CCCPS has diverted an estimated \$4,680 per day in incarceration expenses, resulting in a reported cost savings of \$162,640 for July. Due to this reservation of jail resources, the CCJ can now house inmates from other facilities, generating an additional \$26,080 in revenue. Approximately 20% of the jail population is eligible to produce billable revenue. Our services continue to demonstrate positive impacts, with an estimated mid-year cost savings of \$1,225,870.00.



Currently, the Cass County Jail population is 167 inmates, a 2% increase; 134 Cass County, a 6% increase, 22 Howard County, 11 IDOC. 20% of the jail is non-local housing. The jail is operating at 54% capacity including inmates held for IDOC/Howard. The July average daily population was 167 inmates with a high of 176 and low of 158. 169 inmates, an 26% increase, were booked into the jail in July. This month's jail analysis shows that 15% of inmates are classified as Pre-Adjudication, 25% are Probation/Pretrial/ Community Corrections Violations, 16% are serving an Executed Sentence, 12% are being held on FTA Warrants, 12% are held on Bond Revocations, 12%, 22 inmates, are held for other counties, 4% Parole and 4% fall into the other category, which consists of out-of-county, civil warrants, etc.

In July, the jail housed 28 inmates from the Howard County Jail for a total of 652 days at a per diem of \$40 per day for a total month's revenue of \$26,080.

Community Supervision Violators make up the largest sector of the local population, with 44 inmates held on a pending violation or hold, a 26% increase. 20 are held on pending Probation Violations, with 57% having an additional pending cause/new offense. Currently, 15 inmates are being held on pending Community Corrections Violations, 7 Work Release and 9 Home Detention, while 7 inmates are being held on pending Pretrial Release Violations. 34%, 42 inmates, of those held on a pending cause were arrested with an additional new offense or have multiple cases that elevate their risk to

public safety and the community. Inmates serving an executed sentence make up the second largest local sector of the population with 29 inmates. 57% of the population classified as pre-adjudication have a warrant/hold that excludes them from pretrial release, without judicial override.

The pre-adjudication population is 15% and those detained have been assessed to be a high risk to public safety. The Pretrial Release Program's current release rate is 87%.



CASS COUNTY LOCAL JRAC:

The next Cass County Local JRAC Meeting will be held on August 19, 2025. We are continuing to review local county budgets and fiscal needs, in addition to expanding the therapeutic continuum of care.

Know Your Audience

COST SAVINGS & COMMUNITY IMPACT ANALYSIS | CASS COUNTY COURT & PRETRIAL SERVICES

While the primary focus of Pretrial Services remains to ensure jail resources are reserved for those who truly pose a risk to public safety or flight, one cannot overlook the local monetary savings incurred and the intangible benefits to participants, such as the ability to return to their families and employment and the opportunity to participate in support services pre-disposition. In addition, the Court Services Department provides further fiscal benefit to the county in the multiple grants awarded for various areas in the Criminal Justice System. The purpose of the Cost Savings and Community Impact Analysis is to illustrate the fiscal savings and community impact of the program by analyzing local diversions, community services provided and additional grant funding awarded.

\$1,721,120 Total Cost Savings in 2024

The costs savings for 2024 is calculated by multiplying the total number of days adult clients were supervised by the daily per diem.

118 Years in Jail Bed Stays Diverted

The agency diverted 118 years in jail bed stays in 2024. *Jail Bed Stays Diverted* is calculated by dividing the total days supervised by 365 days.

\$524,160 Jail Bed Revenue Generated

Due to the reduction in the jail population caused by the pretrial release program, the Cass County Jail housed 548 inmates from the Wabash, Carroll, and Howard County jails for a total of 13,114 days, generating \$524,160 in revenue that reverted back to the County General Fund in 2024.

\$1,063,230 2025 Mid-Year Cost Savings

\$182,440 2025 Mid-Year Jail Bed Revenue Generated

82% 2024 Total Cost Savings Rate

The Cost Savings Rate is the percentage of the Total Cost Savings remaining after subtracting the Annual Operating Cost.

43,028 Days Supervised in 2024

In 2024, the agency supervised 363 individual clients for a total of 43,028 days. The agency saw an 20.1% increase in days supervised in 2024 and 30.6% increase in clients served.

\$1,122,577.00 New Grant Revenue Awarded in 2024

Court Services generated over \$1,122,577.00 in new funding in 2024. Court Services has written and been awarded over \$6.6 million in new grant funding/revenue for the County in the past six years












Pima County, Arizona

- 1.063 million (2023)
- Pretrial Services: A distinct division of the Superior Court
- initial Appearance Unit
- Universal Screening:
 - Pre-booking function
 - PSA Court Tool
 - o Supplemental BH/SA screening
 - Release Conditions Matrix (APPR)
- Supervision Unit: Guided by the RCM
- Daily caseload: Ranged from 1,300 to 2,000 over the past few years
- Before incorporating supportive services: Standard community supervision relied on drug testing, offered limited referrals, and experienced a higher technical violation rate.






County Transition Center

- Focus on Misdemeanor Charges
- Transition Center Handoff
- Feedback from Justice System and Community Partners
 - Create opportunities to connect individuals released from custody to essential services (treatment, housing, etc.)





County Transition Center

Transition Center Role

- Not a treatment intervention; rather, it serves as a conduit to resources
- Provides information and enhances access to services and opportunities aimed at breaking the cycle of incarceration

Data Collection

Gather data to identify the most effective interventions

Success Measurement

Evaluate success through reductions in re -arrest rates
 and increases in court appearances



Jail Population Review Committee & STEPs Diversion

New Model for Supervision and Team Decision - Making

- Cooperative Stakeholder Teams : This includes roles such as Prosecutor, Defense, Pretrial Services, Probation, Community Members, Peer Support Specialists, and the County Justice Services Team.
- Pretrial Team: Comprising the Pretrial Supportive Services Specialist, Pretrial Services Officer, Student Intern, and a Peer Navigator (funded through an external organization).
- Key Component: There are no treatment conditions included in the Conditions of Release.
 - Referrals, Assessments, and Treatment : These are monitored by Pretrial Services, with success measured by court appearances and maintaining a record free of arrests (JPR caseload).

Figure 22: Discharge by Percent (N=282)




Figure 23: Gender by Discharge Type (N=282)





Figure D: Distribution of Months to Discharge for Successful Graduates by Year

- Together, we can build a fairer, safer, and more effective pretrial system





Start Small
